Americans for Financial Reform Education Fund (AFR Ed Fund) is seeking interns to help us lead the fight for financial justice. Please note that, due to the COVID-19 emergency, these are all virtual internships, as AFR Ed Fund will continue to take all precautionary measures to protect the health of its staff and the public.

Formed in the wake of the 2008 crisis, Americans for Financial Reform is working to lay the foundation for a strong, stable, and ethical financial system – one that serves the economy and the nation as a whole, rather than a select few, and we are looking for bright interns to join the fight!

Our Mission: Fighting to create a financial system that deconstructs inequality and systemic racism and promotes a just and sustainable economy.

Internships available:

Policy Internships: The policy team is looking for four interns who are interested in economic justice and want to learn more about the financial services industry so they can help make it more inclusive and equitable. The Banking Policy Intern will work with policy analysts to learn about and address financial and regulatory issues related to the banking industry. The Fintech Policy Intern will work with policy analysts to learn about and address financial and regulatory issues related to the institutions that sit outside of the heavily regulated financial system, including FinTech companies. The Housing Justice Policy Intern will work with policy analysts to learn about and address financial and regulatory issues related to housing, including housing affordability, stemming the increasing role of private equity firms and large investors in the housing market, and mortgage lending. The Non-Bank Policy Intern will work with policy analysts to learn about how the current opaque and shadowy nature of non-banks such as hedge funds and private equity firms operate within our economy and financial system.

Responsibilities for the Policy Interns will include:

- Providing research assistance for policy proposals
- Attending virtual and sometimes in-person hearings and providing one pager synopsis
- Writing blog posts, draft press releases, fact sheets, and social media content
- Monitoring and tracking federal and possibly state legislation, as well as news and other sources of information
- Supporting staff engagement and coordination with policymakers, thought leaders, allied organizations and key stakeholders, including preparation for meetings, briefings, hearings or other events
- Administrative duties as assigned
- <u>Consumer Financial Justice Policy and Campaigns Internship</u>: The consumer team is seeking an intern who is interested in working to fight for financial justice. We fight for fair rules and equal treatment for consumers, against lenders who earn profit by taking advantage of people and we promote a strong, effective Consumer Financial Protection Bureau. Having knowledge and experience with Twitter, Instagram, and Facebook platforms is a plus for this position.

Responsibilities for the Consumer Financial Justice Policy and Campaigns Intern will include:

- Staffing and attending meetings with coalition members, policymakers, and other stakeholders
- Developing in collaboration with colleagues and advancing AFR policy priorities in the areas of predatory lending, lending discrimination, debt collection, student debt and other abusive financial practices
- Writing policy memos, regulatory comment letters, reports, and other materials for a range of audiences, including coalition partners, regulatory staff, and Congressional offices.
- Analyzing and responding to policy proposals, legislation, and proposed rules
- Providing support and coordination for AFR's issue task forces in these areas, including building the capacity of AFR's coalition, facilitating collaboration, and developing and implementing strategies to advance our policy goals
- Providing support for a variety of coalition activities, including meetings, actions, briefings, virtual events petition deliveries, Congressional hearings, etc
- Contributing to digital strategy and content for social media accounts
- Engaging in research to highlight the problems in consumer finance and especially drawing connections to the intersection of race, class, finance and politics
- Producing materials that collect and summarize important developments in consumer finance and predatory lending
- Other duties as assigned

• <u>Multimedia Digital Internship</u>: The digital team is looking for a candidate with excellent writing, time management, and organization skills to act as its Multimedia Digital Intern. This candidate must possess strong research skills, a desire to learn, and a strong commitment to racial and gender justice.

Other specific requirements for this role include:

- Experience with modern web development techniques and technologies (Wordpress, HTML, CSS and/or Adobe Creative Suites, Camtasia, Canva, etc.)
- Knowledge of MS Word, Excel, PowerPoint, and file-sharing platforms (Google Drive, Dropbox)
- Video and design capability
- Experience in Search Engine Optimization and Google Analytics is a plus

Responsibilities for the Multimedia Digital Intern will include:

- Maintaining and updating WordPress websites and content including articles, blog posts, and pages
- Assisting in preparing and organizing social media posts
- Using analytics tools to gauge campaign success
- Researching and extracting social media analytics for analysis
- Other duties as assigned

Qualifications:

Ideal candidates must have a strong commitment to racial justice, economic justice, and social justice. They should have excellent written and oral communication skills, high proficiency with general office software (Microsoft Word, Excel, Paint and PowerPoint preferred), and knowledge and experience with social networks. Candidates must also be detail oriented, with solid judgment and good relationshipbuilding skills.

• <u>2023-4 Executive Fellowship:</u> This Internship is a year-long, part-time, paid position. The Executive Intern will report to the COO and provide a range of organizational, operational, and logistical support to the COO and the organization. This is an outward-facing position, meaning the Executive Intern will be in regular contact with people outside AFR/AFREF's staff, including coalition members, the Board of Directors, vendors and service providers and other partners or event participants. An ideal candidate will be attentive to email, organized, detail-oriented, proactive, independent, and able to juggle multiple projects at once.

Responsibilities

- Curate, edit and format monthly reports detailing AFR/AFREF's work for the Board of Directors
- Manage and update the COO Resource Library for DC/Progressive Nonprofits
- Provide logistical and technological support for events, including assistance in the planning, coordination, and production of events
- Assist with Development projects including updating budget spreadsheets and conducting donor outreach
- Provide organizational support for AFR/AFREF operations, such as updating the website and managing subscriptions
- Prepare materials for board meetings
- Complete special projects for the Board of Directors, COO, Operations Manager and Executive Director
